Administrative Changes at CEAEC

Starting with this edition, *Conscientia* magazine will be published by the *International Association of the Center for Higher Studies of Conscientiology* – CEAEC. This new institution, which is responsible for the Administrative management of CEAEC, was founded on July 23, 2002.

Before that time, CEAEC had been managed by a cooperative system under the care of the members of the *International Institute of Projectiology and Conscientiology Collaborators Cooperative* – CEAEC, founded in 1995.

The change of the system from cooperative to association was studied, planned and implemented in order to facilitate a better management of CEAEC's activities within the current Brazilian political and economic context.

CEAEC maintains, under the new administration, its primary objective of being an excellent center for the research and teaching of *Conscientiology*, introducing a universalistic environment for integration, debate, research and exchange of ideas, aiming at the development of this science and its dissemination.

Presently the institution is the headquarters of the activities for the elaboration of the *Encyclopedia of Conscientiology*, an enterprise, led by researcher Waldo Vieira, which will gather a wide array of scientific information on consciousness into a series of volumes. This project receives support and special attention on the part of the team of CEAEC volunteers by virtue of its relevance to consciousnesses who look forward to dynamizing conscious evolution.

In this new stage, *Conscientia* magazine will continue to maintain its editorial quality, accompanying the growth of the results in the field of Conscientiology and bringing to debate ideas, theories and recent experiments in this area.

The following are short comments on the articles in this edition.

The article *Bigorexia* analyses a pathology that can manifest in the intraphysical consciousness who is excessively worried about the appearance of the physical body, at a time in which the cult of the body is becoming intensively present, contributing to the research in the field of Conscientiotherapy.
