Period Previous to the Experiment

I traveled by bus, together with my wife, for approximately 17 hours, leaving from the city of Ribeirão Preto – SP, to participate in an immersion course at CEAEC. Because of that, we were somewhat tired and behind on our sleep.

The Experiment

I entered the *Thosenology* laboratory – a setting for the study of thosenes and their manifestations. I performed the *Basic Mobilization of Energy (BME)* at the entrance door and, soon after, I dedicated some time to the reading of material relevant to the subject.

Settling into the armchair, I performed the BME again, which predisposed me to contact the extraphysical team. I began to obtain insights and ideas that were transmitted to me regarding the theme. After that, feeling very sleepy, I ended up napping. As soon as I began to wake up, while still in the hypnopompic state, I saw my wife sitting on the floor in front of the armchair talking about something.

As there was another female extraphysical consciousness sat at the same level as me, conducting the experiment on the left side of the armchair, I concluded in that moment that it could not be my wife who was projected there, but a fruit of an oneiric image derived from the hypnopompic state. I tried to dismiss her image and to concentrate on the extraphysical consciousness to my side who was concluding her work. There were other consciousnesses in the room and one of them (positioned close to the door) told the one who was at my side to communicate to me that I should forward the report for publication. She didn't need to give me the message, however, because I had already understood.

That was when I realized that my wife actually

could have gone to the laboratory where I was. I had not given the due importance to that fact. I decided that as soon as I left the laboratory I would ask her about it, without telling her the experience that I had, in order not to influence her answer.

Considerations

As soon as I contacted my wife, after the experiment, we confirmed our extraphysical encounter. She affirmed that she was, in fact, projected and speaking to me during her experiment in the *Penta* laboratory, which she was performing at the same moment that I was developing the experiment that I just described. She entered the laboratory and, after completing the BME, came in contact with the energetic dimension, visualizing lights and colors, followed by an energetic bath and energetic donation. She ended up falling asleep and the experiment continued.

At a certain moment, she got scared when seeing a table coming in her direction. At this point, she had not yet noticed that she was projected in the laboratory where I was. To get to the armchair where I had been sitting, she had had to pass first by the table, which was present in the enclosed area. She wanted to say something to me and kept trying to communicate, until a specific instant, after an energetic bath, when she returned to her laboratory and continued her research.

This was not the first time that we were projected together but, during these previous occasions, generally only one of us was lucid. On this occasion, in spite of not having a great lucidity (a fact that I attribute, partly, to my fatigue), both of us remembered the joint conscious projection.

From my perspective, what happened was the underestimation of the phenomenon, confusing a real occurrence with an imaginary one. Frequently I have had this problem and I continue to strive in order to improve my understanding of this differentiation. Fortunately, I have never made this confusion in an inverse way. That is, I have never taken an imaginary event, originating from a daydream or another consciential state, to be a parapsychic effect, because I try to be rigorous in the evaluation of the results of my experiments.
